



PUBLIC INFORMATION / CLERY DISCLOSURE ACT

All Larimore Campus Security Systems are compliant with the reporting mandates of the Clery Disclosure Act.

Campus Security Police reports and Campus Crime Statistics are kept in accordance with the Crime Awareness and Campus Security regulations imposed since 1990 by the Clery Act.

Annual Security Report

- ◆ Required by October of each year, the Annual Security report provides crime statistics for the prior three years
- ◆ Policy statements are submitted regarding various safety and security measures, campus crime prevention program descriptions along with the investigative procedures and prosecution of sex offenses

Crime Log

- ◆ A public log of all reported crimes is to be maintained by the department
- ◆ Each entry in the log must contain the nature, date, time and general location of each crime along with the final disposition of the complaint
- ◆ Crime logs must be kept for seven years, three years following the publication of the last annual security report

Timely Warnings

- ◆ Timely warnings are required for crimes that present a danger to students and campus employees
- ◆ Warnings may be delivered by text, email, pager or other timely manners

Crime Statistics

- ◆ A report of the most recent three years of crime statistics must be available
- ◆ The report is to be listed by crime category and must indicate if any of the reported incidents involved bodily injury of hate crimes
- ◆ Among the crime categories: Criminal Homicide, Sexual Offenses, Robbery, Aggravated Assault, Burglary, Arson, Motor Vehicle Theft and Liquor / Drug / Weapons offenses
